However, since funding for this project has been unexpectedly delayed, the District cannot offer a time frame in which sewer availability will occur. The District will make every effort to work with our engineer and contractor to provide a sewer connection as quickly as possible once funding is guaranteed. In the meantime, we might approach the State Department of Health to discuss other options such as the temporary use of an above-ground holding tank.
