
MINUTES OF ANNUAL MEETING  
February 5, 2004

1. The Annual Meeting was held at the Blue Creek Baptist Church at 7:00 PM February 5, 2004. Present were TCU Directors: Travis Beach, Floyd Ford, Jim Moody, Mike McKinney, Danny Everett, Sandra Hatcher; former Directors Betty Towles and Melvin Bowden; TCU Staff, Sandra Bolton, David Morgan and John Gentry. Approximately 50 visitors also attended the meeting. President Travis Beach called the meeting to order. The first order of business was to pledge allegiance to the flag. Mr. Beach then introduced Taylor County Commissioner Ed Sadler and announced that the County Commission has donated \$15,000 for renovations to the new District Building. Mr. Sadler gave a brief introductory statement of support for TCU.
2. Mr. Beach then introduced the TCU Board of Directors to members of the public attending the meeting.
3. Bob Meissner made a presentation, announcing his retirement after 10 years as General Manager of Taylor Coastal Utilities, and gave a brief history of the growth of the water system. Bob then introduced TCU Staff Jim Gooding, David Morgan, Sandra Bolton and recently hired General Manager, John Gentry. Bob praised Director Floyd Ford for his hard work and dedication to the upcoming sewer project.
4. Travis Beach then presented awards: To former Director Betty Towles for her years of service on the TCU Board; to Melvin Bowden for his 5 years of service on the Board; and to Bob Meissner for his years of dedication and service as General Manager. Sandra Hatcher, newly elected Director, received a vote of confidence to complete Betty Towles term.
5. Travis Beach then opened the floor for nominations for Jim Moody and Melvin Bowden's positions. Jim Moody was nominated by Travis to run. Judy Ferguson, Howie Woods and Glenn Senter were nominated by the audience to run. Travis Beach asked for a motion to close the nomination process. Floyd Ford, motion, Mike McKinney, second, passed unanimously. Paper ballots were passed out and attendees were instructed to vote for two of the candidates. The ballots were collected for counting.
6. Floyd Ford provided an update on the status of the permits and funding for the sewer project. Congressman Allen Boyd is responsible for much of the grant money (4.455M) that is available for Phase I; Rural Development \$2.68 M, OTED, \$375,000, SRWMD, \$620,000 and a \$625,000 loan that is part of the \$2.68 M Rural Development funds and included in the \$4,455 M stated above. Both DEP permits (domestic wastewater and collection system) are issued for the project. Project is currently waiting on a letter of "finding of no significant impact" from the US EPA. Goal is to have the bid package ready by end of February, but this hinges on EPA approval. Start of construction by early April, with 12 months to complete.

7. David Miller said the blessing and refreshments provided by the ladies of the Blue Creek Baptist Church were enjoyed by everyone. During the break, Mr. Sadler stated he is pleased that the Beaches are being so progressive by working to get the sewer system installed.
8. Travis Beach reconvened the meeting at 7:40 P.M. Mr. Beach announced that Jim Moody and Glenn Senter were elected as Directors. The vote was: Moody – 53, Senter – 33, Woods – 32, Fergurson – 18. Judy Stamos, Marcia Parker and Sandra Bolton counted votes.
9. Keaton Beach resident George Stamos commented to the Board that he is concerned there is low water pressure at his house at times. Travis Beach replied that TCU is in the process of completing a feasibility study (FS) for constructing a new well. John Gentry, who is working on the FS, commented that the first part of the FS, a historical data analysis and future needs assessment is complete and indicates that a new well is needed. The second phase of the FS that will analyze options and costs to provide the needed water supply is due by the end of March. The FS will include an analysis of the distribution system and storage facilities to determine what improvements are needed to get the water from the wellfield to residents along the coast. The option of constructing an elevated storage tank will be considered as part of the study. Mike McKinney commented that the Board is actively pursuing getting a new well.
10. Travis Beach explained that the new water rates are now in effect. Large water users are now paying more, but most customers' rates remained the same. The new rates will help with funding for improvements to the water system. Floyd Ford commented that there is high demand on the system during weekends from May through July and that people should try to conserve water on those days to help out until the improvements are completed.
11. Doctor Hutchins asked about the timing for phase II of the sewer system. Mr. Beach indicated that following completion of phase I, phase II will be initiated and will include Dekle and Dark Island south to Fish Creek.
12. Floyd Ford pointed to a map of the District to show how lengthy the District is. He indicated the engineers are looking at alternatives to one large centralized treatment system such as small, dedicated systems for the smaller communities. Floyd discussed the grinder pumps that will connect the services to the system. The pumps are ¼ hp, 110 volt and will come with 25' of cable for a hookup to the residences' electric service. The connection will be elevated to avoid water damage.
13. The meeting adjourned. Motion by Johnny Blue, second by Joe Hatcher, unanimous.

## Grinder Pumps Location

In general, the grinder pump will be located in the area of the existing septic tank. After the installation of the grinder pump, the septic tank will be rendered unusable by caving in the top and filling in with sand or dirt. An owner may have a septic tank removed but will have to pay all cost associated with the removal.

Specific criteria for placing grinder pumps are as follows:

- 1) Water and sewer lines have to be a minimum of six feet (6') apart.
- 2) Sewer line from dwelling must enter grinder pump no greater than 22.8" below grade. (maintains top of grinder pump above grade)
- 3) Sewer line from dwelling must maintain 1/4" per foot fall to inlet of grinder pump (code requirement).
- 4) Location of grinder pump must be within the 10' easement with a five (5') foot clearance around grinder pump. This requires that the centerline of the grinder pump be at least five (5') feet from the adjacent property line.
- 5) User is responsible for all cost associated with relocating his sewer line to the inlet of grinder pump if the grinder pump is not located at the existing septic tank.
- 6) User will pay for all additional cost to locate the grinder pump at a distance from the service line that exceeds the distance that now exist between the service line and septic tank.
- 7) Grinder pumps come with 25 feet of electrical cable. User will pay for any additional electrical cable that may be required to locate the pump at a location other than the existing septic tank.
