Good Morning Commissioners,

I wanted to update you about some security issues we are having at our plants and the District Office.

We had someone on the office porch early Monday morning and a break in at the water plant early this morning.

The intruder at the district office came onto the porch from the side using the ramp and then sat down on the floor and plugged in his phone to the outside power outlet and sat there. Because he came from the side only the doorbell camera was triggered until he was already on the porch which then triggered the front cameras. Because cell service has

been up and down, I did not hear the notification on my phone when he first arrived at 2: 54 a.m. but did when he left the porch at 6:37 a.m. The video shows that he sat down and apparently went to sleep and no other motion was detected until he got up and left.

We don't know exactly when the intruder at the water plant entered but the back camera at the district office was triggered at 5:55 a.m. I looked at the video when it went off and there was nothing on the camera so I assumed it was a bat or spider, which often trigger the camera at night. Ron clocked in at the district office and went over to the water plant. He called me at 6:38 a.m. and reported that there was a three-wheeled type of ATV parked on the roadside between the district office and the water plant and the water plant front office was ransacked with things thrown onto the floor, the refrigerator opened and everything taken or thrown around, and his cat had been either stomped or kicked in the head and was near death. I asked Ron to call 911 and take pictures of the ATV and I headed to the office.

The police arrived within 10 minutes and began photographing, fingerprinting and swabbing for DNA. They called Animal Control for the cat to help determine whether it had been injured by a human or an animal and to put it down. I have given the police all the videos I have and we even checked the game camera that Ron had at the back of the plant but there was nothing on it.

As of 9:07 the police have finished and Animal Control has picked up the cat and will be putting her down. They will then take the cat to Dr. Owens for an exam to determine the possible cause of her injuries. We need this done to help with any court case that might arise as injury to an animal turns a break-in from a misdemeanor into a felony. Ron received a call from a passerby who identified the three wheeler and the police now have that information as well.

David mentioned yesterday that there has been a big increase in the amount of traffic on the road going past the wastewater plant so I had planned to look into a security plan for all of our properties. I will be contacting a few security companies today to have then come and review our properties and get us quotes for coverage.

Good Morning,

The Board has asked me to get your opinion regarding granting water and sewer service to a lot within our District. The property was originally one large parcel (approx. 3 acres) within a subdivision and had never been divided or designated into any lots. This parcel received one water and sewer hookup per the original design of the system. The property owner divided his parcel and sold off 2/3 of the parcel, keeping 1/3 for himself. The portion that was sold contained the original water and sewer hookup. The owner of the now much smaller parcel has asked for water and sewer service. The Board discussed granting service to the parcel as service lines run along the road, but are

hesitant to set a precedent by granting service to a newly created lot. There are a few other parcels within subdivisions served by the District that could be divided, including the remaining 2/3 of the adjoining parcel. Do you believe this would be a violation of our funding agreement with USDA-RD, as they might see this as funding development? Or would this be a natural division of property within a subdivision served by existing lines and therefore be granted service?




