1. The meeting was held in the Blue Creek Baptist Church at 6:30 PM. A light dinner was served.

## **INTRODUCTION for DR. FLOYD A. FALANY**

Let me introduce Dr. Floyd A. Falany, the President of Reinhardt College in Waleska, Georgia.

A native Floridian, Dr. Falany is the youngest of seven children. In his 25 years at Reinhardt, he has served as the Academic Dean, Dean of the College, Executive Vice President and Dean and, for the last 14 years, President.

He donates much of his time to community, county and state civic affairs. In May of 1994, the Cherokee County Bar Association recognized Falany's outstanding community service by presenting him with the 1994 Liberty Bell Award.

Well known and respected in the community, he belongs to the Canton Lions Club and Gideon's International. He is past president of the Cherokee County Chamber of Commerce and has also served on its Board of Directors. He is a member of several Boards of Directors including the First Colony Bank in Alpharetta, Georgia and the Fincher-Loughridge Foundation, Inc. in Dalton, Georgia. He also serves on the Salvation Army's Statewide Advisory Committee for "SHARE," a project designed to aid needy families with their energy costs.

An innovative educator, he has been involved in numerous post-graduate learning experiences and professional organizations. He is on the Boards for United Methodist Church's National Association of Schools and Colleges and the National Council of Independent Colleges. He also serves on the Advisory Board of the East-West Foundation, a Japanese/American group which arranges international educational opportunities.


