MINUTES OF ANNUAL MEETING
February 3, 2000

1. The meeting was held at the Blue Creek Church at 7:00 PM. All directors were present and several guest speakers. 87 members and guests were present. The meeting announcement and the program are attached.
2. The business meeting was held after a light dinner prepared by the ladies of Blue Creek Baptist Church
3. President Travis Beach opened the meeting by welcoming the members and guests. This was the largest Annual Meeting for Taylor Coastal Utilities since it's organization 6 years ago. Mr. Beach welcomed the guests from the Suwannee River Water Management District and thanked them for coming to Taylor County. He expressed the appreciation of the members for the purchase of approximately 45 acres of land around our well field. This was done to protect our water supply.
4. The program was centered on the issue of a central sewer system. Several prominent leaders discussed the problems with septic tank systems in coastal areas and emphasized the need for residents and property owners to take immediate action to protect the quality of life along our coastline.
5. Don Everett, Jr., our Suwannee River Water Management District Governing Board Member, was introduced by Mr. Beach. Mr. Everett introduced Jerry Scarborough, the Executive Director of the Suwannee River Water Management District as the keynote speaker.
6. Jerry Scarborough introduced Brian Kauffman and John Dinges, both water resources engineers for the District, who accompanied him. Mr. Scarborough discussed the problems that are caused by septic tank systems located close to the water, which don't operate properly. He said that recent studies of coastal areas similar to ours found that 80% of the septic tanks were discharging untreated effluent into the adjacent waters. This can cause sickness to swimmers and people eating various kinds of marine life. Many forms of marine life will not live in contaminated water, such as scallops and some fish. Eating oysters that live in contaminated water can cause serious sickness in humans
7. Several of the members of the Utility asked about our chances of getting funding for a central sewer system. Mr. Scarborough reviewed the process to get funds from various sources, and said that the chances of getting 80% to 90% funding from the State and Federal Government were very good at this time. He said that there were several bills before the legislature this year to fund water quality projects for small counties. After additional questions Mr. Scarborough outlined the process for moving ahead with this project. He stated that the first step is a mandatory hook up ordinance for the area. All government funds for sewer and water improvement projects are dependent on the area being covered by an ordinance that requires all those adjacent to service lines to hook up. This is essential in order for the service to be economically justifiable and to provide protection for the health of the public.
8. Other members asked Mr. Scarborough about the cost to the homeowner for central sewer service. He reviewed a system installed in the community of Suwannee. From this experience he indicated

that we could expect no initial connection charge, removal of the present septic system, and a \$30 to \$35 a month sewer service bill. Sewer service would be billed with the water and both will be related to the amount of water used. People who hook up after the initial installation will probably be charged a substantial impact fee to connect. Mr. Scarborough indicated that if a feasibility study were started now it would probably be 4 to 5 years before the system could be operational.

9. Garry Allshouse, the Taylor County Health Department Environmental Supervisor, discussed recent problems with several septic systems at our beaches. He stated that rules are getting tighter and tighter for septic systems in many areas of Florida. He indicated that rules might become significantly more restrictive in the next 5 to 10 years. Mr. Allshouse then outlined the public health hazards associated with improperly treated sewage entering recreational and food producing waters.

10. Floyd Ford, a resident of Keaton Beach, detailed some actual incidents in the past year that have caused sewage to be present on top of the ground because of failed septic systems. Several other members told about failed septic systems and sewage being discharged on the ground or in the water. Mr. Ford discussed a proposed mandatory hookup ordinance that is coming before the Board of County Commissioners Monday, February 7, 2000 for discussion. He urged all members to be at the Commission meeting to show support for the ordinance. He reported that several government agencies have told him that the mandatory ordinance is essential to receiving funds for a sewer or water system. At the end of Mr. Ford's comments he asked for a show of hands of people who would support the mandatory hookup ordinance and the central sewer system. 98% of the group was supportive of the ordinance and the central system. Mr. Ford circulated a paper during the meeting on which people could indicate their support for the central sewer system. After the show of hands and subsequent discussion Mr. Scarborough said that he would do all possible to obtain funding for a feasibility study for the project.

11. Commissioner Ed Sadler assured those present that he supported the mandatory hookup ordinance. He reminded the members that more and more people are moving into the Beach area at quite a rapid pace. The increasing population of our coastal area will make it more difficult to protect our quality of life in the future. This will also make it more difficult and more expensive to install a sewer system in the future. Commissioner Sadler emphasized that it is important to move ahead now when there is a lot of support in State and Federal Government for sewer systems in small rural communities just like ours. Mr. Sadler assured the members of his support in this matter.

12. Three members terms expired this year. Upon motion by Gwen Dixon, second by John Cochran and unanimous vote, directors Betty Towles, Larry Murphy and Travis Beach were elected to another 3-year term.

13. Drawings for door prizes were made and the meeting was adjourned.
