MINUTES OF ANNUAL MEETING
February 6, 2003

1. The meeting was held at the Blue Creek Church at 7:00 PM, February 6, 2003. Present were: Travis Beach, Jim Moody, Mike McKinney, Melvin Bowden, Betty Towles, Danny Everett Commissioners; Jim Gooding, David Morgan, Sandra Bolton, Bob Meissner Staff A quorum was declared. There were approximately 65 people in attendance.
2. The agenda is on the attached sheet.
3. The meeting was opened with the Lords Prayer and the National Anthem.
4. An election was held to select three people for Board Members. The terms of Travis Beach, Betty Towles and Floyd Ford expired this year. Travis Beach turned the meeting over to Mike McKinney, Vice President, to conduct the election. The nominating committee chairman, Melvin Bowden, said that the committee wishes to nominate Travis Beach, Betty Towles and Floyd Ford for the three vacancies. There were no nominations from the floor. The nominations were closed and Travis Beach, Betty Towles and Floyd Ford were elected by acclamation. Motion by Elmer Coker, second by Albert Carter, unanimous.
5. Sandra announced that we had 65% of the easements and we need 85% to obtain out funds.
6. Mr. Jim Burkhart and Garry Allshouse discussed the health concerns at the beaches. They thanked us all for getting the sewer in place. The test results have indicated bacteria are in the water and are a danger to humans swimming or eating fish from the canals.
7. Mr. Tom Parrillo and Glenn Stahl discussed the Environment One grinder pumps. There was a lot of interest from the floor. There was good acceptance of the pumps.
8. Bob Meissner discussed the history of the sewer system and also listed accomplishments of the water company in the past year.
9. John Horvath discussed the progress of engineering work for the sewer system. He predicted that it would be completed by December 2004.
10. Meeting was adjourned. Motion by Joe Hatcher, second by Shelby Gibson.
